**DISTINGUISHING FEATURES OF THE CLASS:** The trainee level is used to recruit candidates to the investigative field who have a career interest in governmental investigations. Trainees receive on-the-job training while performing duties of a limited professional nature. This position involves research and field investigation of individuals and vendors in cases where there is allegation or suspicion of improper amounts of payment and/or attempted or actual welfare fraud. Incumbents are responsible for gathering evidence and documentation, including individuals' statements, to develop legally acceptable cases. Trainee appointments are for a period of one year, following which incumbents receiving satisfactory ratings will be advanced to the title of Social Services Fraud Investigator without further examination.. The work is performed under the close and continuing supervision of the Social Services Investigative Coordinator. The incumbent does related work as required.
